In the late 1990's, Stephen Dickerson, then a professor at Georgia Tech, developed what he claims is the basis for all ridesharing technology-a synergy of cell phones, GPS, and digital payments. He started a company called RideApp, and filed for patent protection. His patent subsequently issued, and in the last year, he filed separate patent infringement lawsuits in U.S. federal district courts
