In recent years, more than 40 percent of patent lawsuits in the United States have been filed in the Eastern District of Texas—a court with a reputation for friendliness to patent owners of all types, whether individual inventors, operating companies, or perhaps most notably non-practicing entities (sometimes disparagingly called "patent trolls"), which are known for buying patents not to use them but to demand royalties. A single federal judge based in Marshall, Texas, has been overseeing about a quarter of all patent cases nationwide—more than the number handled by all federal judges in California, Florida, and New York combined.
